



## RESIDENTIAL TENANCY APPLICATION REQUIREMENTS

In order for you to be considered for a rental property, **it will be necessary for you to view the property**, complete the Tenancy Application and meet the 100 point requirement. To meet our 100 points you need to supply original documentation that will be copied and kept on our file. Identification may consist of:

- When vacating, you need to have the telephone disconnected and the gas electricity metre read and disconnected.
- Have your mail re-addressed to your new address
- Always pay your rent on time.
- You are responsible for water usage and electricity usage
- Do not park cars on lawns or nature strips
- In an emergency phone Ann or Kimberley on their mobile number BEFORE any other action is taken.
